

Terms and Condition for Siddhartha Law College National Online Quiz Competition

2) To be eligible to take part in the Constitutional Quiz Competition, the Participants need to conform to the following eligibility criteria: **Undergraduate and Postgraduate Law Course Students**

- a. An Individual;
- b. An Indian citizen;
- c. Residing in India;
- d. Aged 18 years and above;
- e. Legally eligible to enter into a contract;
- f. Must have a valid Email ID (as applicable)
- g. Proper Username of that email id

3) To participate in the Constitutional Quiz Competition using Email ID, the participant/s has to follow the following steps:

- a. Click on the given Google Form Link (<https://forms.gle/tWYjhsYFLudkBmbV7>) and has to Follower on the Facebook page (**sgi.dehradun**) **Siddhartha Group Of Institution**.
- b. Participants should fill in the information (or as applicable) and enter through the registration form.
- c. After Submission of the asked questions, the form will reflect the message of successful registration on National online quiz to the Participant/s.
- d. The proviso that the registration without the payment of prescribed registration fee will be provisional, not final in nature.
- e. The participant/s can participate in the National Online Quiz Constitutional Quiz Competition who has final registration and not the Participant/s with the Provisional registration.

- 4) The National Online Quiz on Constitutional Law in India will be held on 6th August 2020 (Thursday). Timing will be notified through Email once you registered with us.
- 5) On the said date of Constitutional Quiz Competition the Participant/s will receive a link from the Siddhartha Law College, Dehradun at Google Classroom just before the commencement of the Constitutional Quiz Competition in the Email ID given by the Participant/s at the time of Registration.
- 6) Students are required to download Google Classroom Application for the mobile and for the Personal computer they can directly login via browser.
- 7) This Constitutional Quiz Competition will contain **120 questions** under which all will be multiple-choice questions. The time limit will be **90 minutes**.
- 8) After the Constitutional Quiz Competition Period, a panel of jury will select 3 winners (or as applicable) of the Constitutional Quiz Competition and E-Certificate will be given to all the participants. If the Winners scores got ties they will be given 20 More Questions and from that winner will be declared and further Siddhartha Law College is free to take any decision regarding the declaration of winners.
- 9) The result will be declared by Siddhartha Law College after a week of the Constitutional Quiz Competition week Period on the mentioned Facebook page i.e. [@\(sgi.dehradun\)](#) Siddhartha Group Of Institution.
- 10) The prize amount will be distributed among the winner/s as follow
 - a. **First winner - Rs.2000/- (Rupees Two Thousand only)**
